For a Pistol/Carbine Purchase to qualify under this program, the following instructions must be followed:

- 1) Complete a Purchase Authorization Letter (PAL) following the directions below **OR** submit a copy of the appropriate credentials (ID, badge, etc.).
- 2) Complete the attached Rebate Form.
- 3) Mail the PAL **or** Credentials, and Rebate Form, together with a copy of your pistol/carbine receipt, to Beretta USA Corp., Attn: America's Defenders Pistol Purchase Program, 17601 Beretta Drive, Accokeek, MD 20607. Please allow 4-5 weeks for your rebate check to arrive.
